WHEREAS, it is the desire of West Sound Utility District ("District") to dispose of personal property and equipment owned by the District and SKWRF that is no longer needed; and


WHEREAS, RCW 57.08.015 governs the process and procedures for the disposal of surplus personal property; NOW, THEREFORE,

THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT HEREBY RESOLVES:



APPROVED and ADOPTED by the Board of Commissioners of West Sound Utility District at a regular scheduled meeting on November 7, 2016.


