WHEREAS, the District staff secured competitive bids for the excavator and trailer from several vendors; and



THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT HEREBY RESOLVES:



APPROVED and ADOPTED by the Board of Commissioners of West Sound Utility District at a Board meeting scheduled on March 12, 2018.


