WHEREAS, on June 18, 2018, after the Board of Commissioners conducted a public hearing, the Board of Commissioners has determined that the proposed annexation of the Aiken Road South properties into the District's sewer service boundaries, comprised of 48.74 acres, should be approved; and



HEREBY RESOLVES:**

Section 1. The properties identified in the attached legal description (Exhibit "A") are hereby annexed into the sewer boundaries of the District and is hereby declared to be within the sewer jurisdictional boundaries of the District effective immediately.

APPROVED and ADOPTED by the Board of Commissioners of West Sound Utility District at a Regular Board meeting scheduled on October 1, 2018.



**Sewer Annexation
Aiken Road (South)**

Those portions of Section 6, Township 23 North, Range 2 East, W.M., Kitsap County, Washington, described as follows:

The Southeast quarter of the Southwest quarter EXCEPT the North 20 feet

ALSO EXCEPT that portion annexed by West Sound Utility District Resolution 722-18 dated May 21, 2018.

EXCEPT any portion thereof lying Easterly of the East line of the following parcels:

Resultant Parcel "A" of that certain Boundary Line Adjustment recorded under Auditor's File Number 9611060196

Resultant Parcel "A" of that certain Boundary Line Adjustment recorded under Auditor's File Number 200303240162, records of Kitsap County;

Resultant Parcel B of that certain Boundary Line Adjustment recorded under Auditor's File Number 3157822, records of Kitsap County

EXCEPT the South 30 feet of said Southwest quarter of the Southeast quarter lying Easterly of the Southerly extension of the East line of Resultant Parcel "B" of that certain Boundary Line Adjustment recorded under Auditor's File Number 3157822

ALSO the Southwest quarter of the Southeast quarter

EXCEPT any portion thereof lying Easterly of the East line of the following parcels:

Lots 41, 42 and 51 of the Plat of Albert B. Lord's Salmonberry Lodge as filed in Volume 4, page 13 of plats

Resultant Parcels 1 and 2 of that certain Declaration of Partition recorded under Auditor's File Number 201408280069

Resultant Parcel "A", "C" and "D" of that certain Boundary Line Adjustment recorded under Auditor's File Number 9611060196

TOGETHER WITH that portion of Section 7, Township 23 North, Range 2 East, W.M., Kitsap County, Washington described as follows:

The North 330 feet of the Northeast quarter of the Northwest quarter thereof

EXCEPT the North 30 feet of the said North 330 feet lying Easterly of the Southerly extension of the East line of Resultant Parcel "B" of that certain Boundary Line Adjustment recorded under Auditor's File Number 3157822

ALSO EXCEPT the West 30 feet of the said North 330 feet of said Northeast quarter of the Northwest quarter
