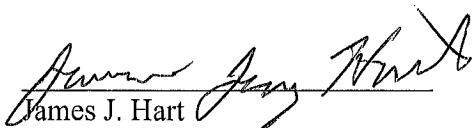

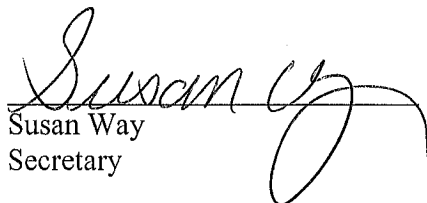
**THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT
