**A RESOLUTION OF THE
WEST SOUND UTILITY DISTRICT BOARD OF COMMISSIONERS
APPROVING THE 2013 SALARY SCHEDULE AND MODIFICATIONS TO THE
DISTRICT'S PERSONNEL MANUAL**

WHEREAS, West Sound Utility District Board of Commissioners has determined that a cost of living adjustment should be implemented for District employee's wages for 2013; and

WHEREAS, in order to provide a more competitive and equitable compensation formula for District staff, certain employee pay grades should be adjusted; and

WHEREAS, West Sound Utility District Board of Commissioners approved on December 20, 2010, Resolution 237-10 which established personnel policies for the District; NOW, THEREFORE,

**THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT
HEREBY RESOLVES:**

Section 1. The attached Wage and Salary Schedule, Exhibit "A", is hereby approved and shall be effective on January 1, 2013. The General Manager is covered by an employment contract with the District and is, therefore, exempt from the Exhibit "A" salary schedule.

Section 2. The following positions are designated "exempt employment positions" pursuant to the Fair Labor and Standards Act: Plant Manager, Customer Service Manager, Operations Manager, Information Technology Manager and General Manager.

Section 3. Section 3.2, "Wage or Salary Increase Policy", of West Sound Utility District's Personnel Policies (Resolution 237-10) is hereby amended to read as follows:

"Pay Anniversary Dates. An employee's pay anniversary date is the anniversary of his/her initial pay increase or promotion to a higher pay grade.

Those positions which have pay grade changes will be eligible to advance to the next step of the new pay grade on their pay anniversary dates, upon satisfactory completion of their performance evaluation.

The District wage and salary policy provides for step by step progression. . ."

Section 4. The following employees are hereby approved to be promoted to a new job classification effective January 1, 2013: Deena Carpenter (Customer Services Assistant to Customer Services Representative), Joy Ramsdell (Accounting Clerk to Accounting Specialist), Brian McCown (Operator Trainee to Plant Operator), Heidi Hill (P/T Accounting/Administrative Clerk to P/T Accounting/Administrative Assistant), Dale Webb (Inspector/Utility Specialist II to Inspector/Utility Specialist III) and Michael Whitehead (Network Administrator to Information Technology Manager).

Section 5. The contribution the District shall make to the employee's monthly health insurance benefit shall remain at \$950/month through fiscal year 2013.
