**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF
WEST SOUND UTILITY DISTRICT AUTHORIZING THE
CONTINUATION OF JANITORIAL SERVICES
WITH ABM JANITORIAL SERVICES**

WHEREAS, commencing on January 1, 2011, West Sound Utility District decided to use a janitorial contract service instead of a full time employee to provide janitorial service for the District administration and operation facilities; and

WHEREAS, the District selected and entered into a one year janitorial services agreement in 2011 and 2012 with ABM Janitorial Services at a contract service rate of \$853.55 per month; and

WHEREAS, it is the desire of the District to extend the janitorial services contract with ABM Janitorial Services for another year (January 1, 2013 - December 31, 2013); NOW, THEREFORE,

THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT HEREBY RESOLVES:



The extension of the janitorial services contract with ABM Janitorial Services from January 1, 2013 through December 31, 2013 is approved, and further authorizes the General Manager to execute a contract extension agreement with ABM Janitorial Services at a service rate of \$892.59 per month, plus applicable taxes.

APPROVED and ADOPTED by the Board of Commissioners of West Sound Utility District at a regular scheduled meeting on December 17, 2012.






