RESOLUTION 452-13**

**A RESOLUTION OF THE  
WEST SOUND UTILITY DISTRICT BOARD OF COMMISSIONERS  
AMENDING SEWER RATES, FEES AND CHARGES**

**WHEREAS**, RCW 57.08 authorizes water and sewer districts to establish water and sewer rates; and

**WHEREAS**, the District adopted on February 19, 2013, Resolution 414-13 which established new water and sewer rates, fees and charges; and

**WHEREAS**, within the adopted Resolution 414-13, the District eliminated using “winter months water consumption averaging” for purposes of calculating non-residential sewer utility rates; and

**WHEREAS**, there are some non-residential customers who have been adversely impacted by this sewer rate formula change; NOW, THEREFORE,

**THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT  
HEREBY RESOLVES:**

**Section 1.** Section 5 of Resolution 414-13 (Sewer Rates) is hereby amended to read as follows:

“**Sewer Rates.** The following sewer rates are applicable:

1. **Residential:** The monthly sewer service rates for single family residential properties are as follows:

\$51.50 per month per residential living unit.

2. **Multi-Family:** The monthly sewer service rates for multi-family properties, which include duplexes and larger projects, are as follows:

\$51.50 per month per residential living unit.

3. **Non-Residential:** Non-residential accounts include schools, commercial, industrial, and similar type usage. The water consumption calculation shall be based on the monthly water consumption. The monthly sewer rate for Non-Residential accounts is as follows:

\$40.00 for customer base rate; \$6.50 for each 100 cubic feet of water consumed


Non-residential accounts will be allowed to average winter water consumption falling between November through March to determine the spring/summer sewer rates for sewer utility service falling between April and October. Such allowance shall be upon application and with appropriate justification that additional


spring/ summer water usage does not enter the sewer system. Sewer utility service for the months of November through March shall be billed per actual water consumption at the rate noted above.



**WINTER AVERAGING APPLICATION
