**WHEREAS**, West Sound Utility District and the City of Port Orchard entered into an interlocal agreement on January 31, 1983, for the management and operation of the South Kitsap Water Reclamation Facility; and

**WHEREAS**, the District and City entered an agreement on July 16, 2012, to extend the 1983 interlocal agreement until December 31, 2013; and


**WHEREAS**, it is in the best interest of the District and City to extend the term of this interlocal agreement for an additional sixty (60) days; NOW, THEREFORE,


**THE BOARD OF COMMISSIONERS OF WEST SOUND UTILITY DISTRICT

**WEST SOUND UTILITY DISTRICT AND CITY OF PORT ORCHARD  
FOR WASTEWATER FACILITIES MANAGEMENT**

This Amendment to the Wastewater Facilities Management Agreement is made and entered into on this 11 day of December, 2013, by and between West Sound Utility District (hereinafter referred as "District") and the City of Port Orchard (hereinafter referred to as "City").

**WHEREAS**, the District and the City entered into an interlocal cooperative agreement on January 31, 1983, for the management and operation of the South Kitsap Water Reclamation Facility (hereinafter referred to as "Facility"); and

**WHEREAS**, on August 14, 2012, the District and City entered into an agreement to extend the term of the 1983 interlocal cooperative agreement until December 31, 2013; and

**WHEREAS**, there is mutual desire and interest of the District and City to extend the term of the 1983 Agreement for an additional sixty days in order to provide the District and City the opportunity to complete the preparation of a new interlocal cooperative agreement; NOW, THEREFORE,

**THE CITY AND DISTRICT, THROUGH THEIR RESPECTIVE LEGISLATIVE BODIES, HEREBY AGREE AS FOLLOWS:**

1. Term of Contract. The term of the Interlocal Cooperative Agreement entered into on January 31, 1983, by and between the City and District for the management and operation of the Facility and the term of the August 14, 2012 Extension Agreement shall be extended until March 1, 2014. All other terms and provisions of the 1983 Agreement shall remain in effect and are incorporated by reference as if fully set forth herein.
