AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of West Sound Utility District No. 1 from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Third party billing and cash receipting
- Utility billing
- General disbursements
- Payroll – gross wage and overtime recalculation
- Cash receipting

INFORMATION ABOUT THE DISTRICT

In November 2007, the rate payers of Annapolis Water District and Karcher Creek Sewer District voted to consolidate the districts and form West Sound Utility District. The District provides water and sewer service to approximately 6,412 customers.

The District is governed by three-member Board of Commissioners. In 2016, the District operated on an annual budget of approximately \$20.1 million and \$17.8 million in 2017. The District had 21 employees. The District is also responsible for managing the operations of the South Kitsap Water Reclamation Facility. The Facility is a joint venture between the District and the City of Port Orchard for wastewater treatment.
